



CONTRACT FOR PURCHASE OF A Bengal Buddies Cat

This contract is between the **Seller, Bengal Buddies (BB)**, and **Buyer**, _____ (Buyer), dated this ____ day of _____, _____ (Contract).

BENGAL BUDDIES AND BUYER AGREE AS FOLLOWS:

1. Purchase Price

Buyer shall pay to BB the amount designated below (Purchase Price) for the purchase of the Bengal cat (Cat) described in paragraph 2:

The Purchase Price shall be paid in full to BB by Buyer prior to delivery of the Cat. Any deposit paid by Buyer shall be credited against the Purchase Price. The Purchase Price does not include any additional fees or costs related to delivery of the Cat or otherwise (*i.e.*, shipping related fees, required travel documentation).

2. Description of Cat

3. BB's Right of Refusal to Complete Sale

Notwithstanding anything to the contrary herein, BB reserves the right, in its sole discretion, to refuse sale of the Cat prior to delivery. In the event BB exercises this right, BB shall return to Buyer any Purchase Price paid.

4. Buyer Representations

- a. Buyer is purchasing the Cat for Buyer's personal use, not for any third party, and for the purpose of companionship and pleasure.
- b. The Cat will be treated with care and affection. Buyer will provide the Cat with proper nourishment, housing, social attention and protection. Buyer will not abuse, neglect or mistreat the Cat. If an animal welfare agency or credible, verified third party complainant alleges that the Cat has been abused, neglected or mis-treated while owned by Buyer, BB shall have the right to repossess the Cat, and Buyer shall surrender the Cat with no Purchase Price refund to Buyer.
- c. Buyer assumes responsibility for the health and welfare of the Cat. Buyer will provide appropriate wellness and illness veterinary treatment.
- d. The Cat will never be sold, transferred, leased, or given away to any pet shop, research laboratory or similar facility.
- e. Buyer will notify BB if the Cat is sold, and provide the contact information of the new owner.
- f. Buyer will not euthanize the Cat without obtaining prior written approval from BB.
- g. Buyer will not abandon the Cat or turn it over to an abandoned animal shelter.
- g. Buyer agrees that it:
 - i. Is familiar with the TICA, ACFA or other Bengal Standard;
 - ii. Has inspected the Cat in person or through photographs and compared it to the Bengal Standard;
 - iii. Agrees that the Cat's features compared to the Bengal Standard are satisfactory to the Buyer; and
 - iv. Understands that this Contract does not provide any performance or cat show achievement guarantee.

5. Seller Representations

- a. The Cat is a Bengal. A certified TICA Bengal pedigree will be provided to Buyer along with a Breeder Slip to allow Buyer to register the Cat with TICA as a Bengal.
- b. At the time the Cat is delivered to Buyer, it will have been altered (spayed or neutered depending on sex) and will have been examined by a licensed veterinarian. The Health and immunization record of the Cat will be provided to Buyer.

6. Seller Guarantees

- a. Health of the Cat is guaranteed as specified within this paragraph; No other guarantee is provided except as specified herein.
- b. If, within five (5) days of delivery of the Cat, the Cat is found to be medically deficient, Buyer may, at Buyer’s discretion, return the Cat and receive a refund of the Purchase Price, or receive a replacement cat of equal quality within a reasonable time of BB having one available. In order to exercise its right under this paragraph, the Buyer shall provide to BB, within twenty-four (24) hours of the diagnosis:
 - i. Written notice to BB of the diagnosis;
 - ii. A written certification from a licensed veterinarian confirming the diagnosis, likely outcome and professional conclusions that the condition renders the Cat medically deficient and was present at the time of delivery;
 - iii. A written certification that the Cat has not been exposed to a cat with the disease; and
 - iv. A written certification by Buyer that Cat has been quarantined from other cats since delivery of the Cat.
- c. If, within twenty-one (21) days of delivery of the Cat, the Cat is found to be medically deficient with an untreatable or life-threatening problem, Buyer may, at Buyer’s discretion, return the Cat and receive a refund of the Purchase Price or receive a replacement cat of equal quality within a reasonable time of BB having one available. In order to exercise its right under this paragraph, the Buyer shall provide to BB, within twenty-four (24) hours of the diagnosis:
 - i. Written notice to BB of the diagnosis;
 - ii. A written certification from a licensed veterinarian confirming the diagnosis, likely outcome, and professional conclusion that the condition was present at the time of delivery;
 - iii. A written certification by Buyer, that it has kept the Cat quarantined from other cats for twenty-one (21) days after delivery of the Cat; and
 - iv. A written certification that the Cat has not been exposed to a cat with the disease or a cat lacking proof that it is FeLV and FIP free.
- d. If within thirty (30) days of delivery of the Cat, Buyer decides that the Cat’s temperament is unsatisfactory, Buyer may return the Cat and receive a refund of the Purchase Price.
- e. If the Cat dies of a genetic or congenital defect before it is two (2) years of age, BB will replace the Cat with a Cat of equal quality within a reasonable time of BB having one available. In order to exercise its right under this paragraph, the Buyer shall provide to BB, within thirty (30) days of the Cat’s death:
 - i. Written notice to BB of the death; and
 - ii. A written autopsy performed by a licensed veterinarian confirming the cause of death.

7. Non-Transferability or Assignability of Contract

This Contract is between BB and Buyer and may not be transferred or assigned to any other party.
